

Job Description Debt and Development Coalition Ireland Campaigns & Outreach Support Officer

Debt and Development Coalition Ireland is seeking to recruit a campaigns and outreach support officer with energy and passion for global justice work, on a 1 year contract. This post will support DDCI to deliver an exciting plan of campaigns work on the themes of international debt and tax justice. It is an exciting role that requires excellent creative campaigning and communication skills.

The role involves driving the campaigns operations, and outreach to our members and the public, through campaigning, education and social media opportunities.

The successful candidate will have a strong commitment to DDCI's values and mission, be an enthusiastic activist, with excellent campaigning, communication and organisational skills. The person must have experience of working with activist or advocacy organisations (paid or voluntary) and be generally familiar with current debates on international financial justice.

The role:

Key allies in this role: The DDCI membership, Irish civil society organisations (CSOs), international debt and tax justice colleagues.

Contract Duration and Salary

This is a 1 year contract (starting early February 2014), 4 days per week. The salary is € 30,945 - € 35,163, depending on experience, on a pro rata basis.

Key Duties

The key duties will include the elements below with primary responsibility in the areas of campaigning, communications and outreach, and organisational administration.

Responsibility Key Duties

Priority Area

Campaigning and public engagement

- Promoting 1 major debt justice campaign and 1 major tax justice campaign in 2014. This includes being involved with a small team in supporting popular campaign planning and implementation.
- Ensuring our popular campaigns are actively engaged with during specific times during 2014 – including the Global Week of Action on Debt (Oct) and the European Tax Solidarity Week (Nov)
- Reaching out to specific stakeholder groups to join in our popular campaigns eg: to faith-based communities, through promoting a faith-based statement on the financial crisis and collecting signatories from multi-faith leaders

Linking our education and campaigns work

- Promoting our campaigns through planning face-to-face events, meetings and workshops with our members and the public.
- Facilitating a voluntary campaign action group to support popular campaign planning and implementation
- Leading on launching and promoting a forthcoming popular economic critical literacy education tool called 'econo...wha?'.

Communications

- Leading on evaluating our website and redesign
- Updating facebook, twitter & the website on a daily basis
- Sending newsletters and e-updates to our members and the public
- Developing a membership pack for DDCI members Supporting with general office administration including:
